COACH PASS £10 per club, includes programme & poolside refreshments.

RELAY Teams must consist of 2 male/open and 2 female swimmers. One from each age group (which is 8-10,11-12,13-14 & 15+). Clubs may swim athletes up an age group where they do not have sufficient numbers in an age group. Clubs can enter more than one team. In the event that the morning events are oversubscribed, the relay may be dropped from the meet.

AWARDS Medals will be presented to 1st – 6th place in each sprint final.
The relay will be heat declared winners and medals will be presented 1st – 3rd place.
Medals can be collected from the medals table in the spectator's gallery.

OFFICIALS Clubs are asked to provide a minimum of 2 technical officials per session. Please forward Names/positions (and whether mentoring is required) to bathgateasc.sto@gmail.com

Entries should be made via Hy-Tek entry files which can be downloaded from Swim Scotland or by emailing the Meet Manager quoting your club name. Entries should be received by noon Friday 31st October 2025.

It is the responsibility of entry secretaries to ensure all entry times and DOBs are correct.

Meet Rules

- The meet will be held under SASA rules.
- The meet is licensed and a level 3 accreditation has been awarded.
- All swimmers of Scottish clubs must have a current SASA registration number. All swimmers of non-Scottish clubs must be registered with their governing body.
- The meet will be in accordance with SASA's Transgender & Non-Binary Competition Policy
- 6 lane, 25 metre competition pool. Anti-wave lane ropes. Spectator area.
- Electronic timing will be in operation. In the event of electronic failure, back-up manual timing will be used.
- No photographic or video equipment will be allowed in any area under the jurisdiction of the meet organisers without prior approval of the meet director. Application must be made on the attached SASA form.
- Withdrawals must be made to the recorders no later than 45 minutes prior to the start of each session.
- It is the responsibility of each club to ensure that their swimmers are aware of the meet rules and guidelines.
- The organisers reserve the right to restrict entries if required to allow for the smooth running of the meet. Rejected entries will be refunded in full.
- There are no refunds for entries withdrawn after the draft programme is prepared.
- Over the top starts may be used at the discretion of the promoter to facilitate the smooth running of the meet.
- Swimmers must report to the competition stewards in the designated marshalling area at least five heats in advance.
- Neither Bathgate ASC nor Xcite Leisure Centre Bathgate can be held responsible for loss or damage to swimmers', team staff or spectators' property. Swimmers should secure their belongings in the changing rooms and not leave belongings unattended.
- Swimmers & coaches must not take glassware into the showers or on to poolside.
- Outdoor footwear must not be worn on poolside.
- Swimmers MUST wear dry clothing and footwear at all times when not in poolside area.
- Lunch will be provided for officials.
- Anything not covered above and not printed in the event programme will be at the organisers discretion.
- Bathgate Amateur Swimming Club reserves the right to vary the above conditions as necessary.
- Transgender & Non-Binary Competition: The Scottish Swimming Transgender & NonBinary Competition Policy was implemented on 1st January 2024. The policy and FAQs can be found at <https://www.scottishswimming.com/about-us/equality>. Any policy related matters that arise during the event should be reported to and will be recorded by the Meet Convenor/Lead Referee and these matters will be communicated to and managed post event by the relevant Scottish Swimming Staff. At no point will members be challenged on the day of a competition with any matters being resolved post event. By entering the Female category, athletes are therefore confirming their birth sex is female and are eligible to compete in the Female category.

- Safeguarding: The primary safeguarding point of contact for the event in relation to wellbeing & protection matters or accidents is the Meet Organiser. The secondary point of contact is the Scottish Swimming Safeguarding Manager.
- Scottish Swimming “Swimwear Policies” shall apply. Bylaws BL 8.2 and BL 8.3 cover the requirement for design and material.

* Whilst it is acknowledged that parents/carers wish to celebrate the achievements of their own children when taking part in aquatic events, it should be recognised and respected that other parents/carers may not wish for their child's image to be taken and shared in this way.

* The meet organisers are committed to ensuring that all children who participate in this meet are able to take part in an enjoyable, safe environment and be safeguarded from harm.
