Date: Saturday 6th December 2025

Venue: Mercat Gait Centre, Prestonpans, East Lothian, EH32 9EN

Pool: 6 lane, 25 metre pool with anti-wave lane ropes; full electronic timing with 3 lane display board. The pool

has a spectator area.

Ages: Age on day of meet.

Age Groups: Session 1: 9 years and under, 10-11 years

Session 2: 11-12 years, 13-14 years, 15+ years

11 year olds should enter only one of either the morning session or afternoon sessions.

Awards: Medals for top 3 in each age group. There will be presentations in the AM session and a medal table for

the PM session. Medals can be collected in the afternoon following the posting of results.

Xmas spot prizes will be awarded to winners of randomly selected heats. These heats will be made

known prior to the heat start.

Events: All events are heat declared winners. All events will be swum as open and split for results into age groups.

Sessions: Session 1: 9am warm up for 9:45am session start.

Session 2: 1:30pm warm up for 2:15pm session start.

Relays must be made up of 2 girls and 2 boys.

Morning relays must consist of 2 swimmers aged 9+Under and 2 swimmers aged 10-11 years Afternoon relays must consist of 2 swimmers aged 13+Under and 2 swimmers aged 14+Over

Rules

- The current World Aquatics and SASA rules of competitive swimming will apply.
- The meet shall be run in accordance with SASA's Transgender & Non-Binary Competition Policy.
- All events will be **Heat Declared Winners**.
- All swimmers must have a current SASA or equivalent registration number.
- Age is as on day of competition.
- Electronic timing will be in operation. In the event of electronic failure, back-up manual timing will be used.
- The organisers reserve the right to restrict entries to allow for the smooth running of the meet. Rejected entries will be refunded in full
- Swimmers must act on the instructions given by the meet officials and behave in a reasonable manner at all times.
- It is the responsibility of each club to ensure that their swimmers are aware of the meet rules and guidelines.
- Swimmers must report to the designated marshalling area **a minimum of four heats in advance.** It is the responsibility of the clubs/coaches to ensure that their swimmers report to marshalling on time.
- Over the top starts may be used to help the smooth running of the event.
- IN THE EVENT OF THE MEET BEING OVERSUBSCRIBED, ONLY 'A' TEAMS WILL BE ACCEPTED FOR RELAY EVENTS

Warm Up

- Warm up may only commence when advised to do so.
- Diving only in sprint lanes when introduced.
- Meet stewards will determine sprint lanes.
- No congregating allowed at either end of the lanes.

Miscellaneous

- The use of mobile phones is prohibited in the changing rooms.
- The organisers reserve the right to exclude or refuse admission to any competitor, spectator, or team official.
- Neither Tranent ASC or the Mercat Gait Leisure Centre can be held responsible for loss or damage to any property.
 Swimmers should use the lockers provided and not leave belongings lying around unattended. Bags should be stored in lockers and not brought onto poolside.
- Any belongings left in unlocked lockers or changing rooms will be removed.
- Swimmers must act on the instructions of meet officials and behave in a responsible manner at all times.
- No glassware may be taken into showers or poolside. Anyone doing so will be liable to expulsion from the meet.
- Outdoor footwear must not be worn on the poolside area.
- Swimmers MUST wear dry clothing and footwear at all times when not on the poolside area.
- The Tranent ASC committee retains the right to amend any of the above conditions as necessary.
- Anything not covered in the above or in the event programme will be at the organisers' discretion.

Swimwear Policy

Swimwear Aquatics GB and Scottish Swimming advise that World Aquatics BL8.1 only applies to Olympic Games and World Aquatics events. A suit check will only be made if a World or European record is claimed. There is no requirement for officials to check that costumes are on the approved World Aquatics list. Bylaws BL 8.2 and BL 8.3 cover our requirement for design and material.

• SW8.0 Scottish Swimming Rules • SW8.8 Swimwear Policies SW8.8.1. For events held under the direct jurisdiction and control of Scottish Swimming the Scottish Swimming "Swimwear Policies" shall also apply. The policies are included in full in the appendices of Scottish Swimming Regulations. These can be found here. Transgender & Non-Binary Competition

The Scottish Swimming Transgender & Non-Binary Competition Policy will be implemented as of 1st January 2024. The policy and FAQs can be found HERE. Any policy related matters that arise during the event should be reported to and will be recorded by the Meet Convenor/Lead Referee and these matters will be communicated to and managed post event by the relevant Scottish Swimming Staff.

At no point will members be challenged on the day of a competition with any matters being resolved post event. By entering the Female category, athletes are therefore confirming their birth sex is female and are eligible to compete in the Female category. Safeguarding The primary safeguarding point of contact for the event in relation to wellbeing & protection matters or accidents is the Meet Organiser. The secondary point of contact is the Scottish Swimming Safeguarding Manager.
